Sewer Rate Changes Effective August 1, 2018

The Board of Trustees held a Public Hearing on Tuesday, June 19, 2018 at the Kingsbury GID Office and approved sewer rate increases for five (5) consecutive years. The increases are necessary to fund increasing operational costs, capital improvements and to maintain fund balance and cash reserves. Please contact our office with any questions. The Tables below summarize the approved sewer rate changes beginning August 1, 2018:

Residential customers, except timeshare units, will see their rates increase from \$53.75/mo. to \$56.98/mo.

<u>Timeshare</u> properties will pay the base rate per timeshare unit which includes 4,000 gallons for each unit. All additional water use above the allowed amount will be charged at \$16.28/1,000 gallons.

Commercial will be charged the base rate for each equivalent dwelling unit and a consumptive rate of \$16.28/1,000 gallons calculated on the actual water consumption above allowed consumption. For example, a restaurant that is equivalent to two (2) dwelling units and uses 75,000 gallons of water per month, will be billed a base rate of \$113.96 (\$56.98x2) and a consumptive rate of \$1,090.76 (75,000 gallons less 8,000 (4,000 x 2 units) gallons allowed = 67,000, 67 x \$16.28 = \$1,090.76). Therefore, the total sewer bill will be \$1,204.72 (\$113.96 + \$1,090.76).

<u>Commercial with irrigation</u> will be charged the same as Commercial above, except, their bill will be based on average winter water use as calculated for the months of November through March.
