# What's on Tap?

## Rate Effective July 1, 2019

The Board of Trustees held a Public Hearing on Tuesday, August 25, 2015 at the Kingsbury GID Offices and approved water rate increases for four consecutive years. The increases were necessary to fund debt service for the new Water Treatment Plant. The Tables below summarize the approved water rate changes effective July 1, 2017 for year three (3) of four (4).

The last approved increase of 3% went into effect July 1, 2018. Note: The above water base rates will be separated into 5 components on the bills.

***KGID Connection Permit required for changes to property***

*The District requires connection permit applications when making changes to properties including remodeling, partitioning of existing structures, new construction and changes or replacements of service lines. The District adopted the Uniform Plumbing Code requirements for determination of sizing service lines, meters and building supply lines. Please be aware that additional connection fees and plan review fees may be due for such changes to your property including costs incurred to implement requirements.*
