KINGSBURY GENERAL IMPROVEMENT DISTRICT RESOLUTION 2022-X

A Resolution adopting an increase to the snow removal fee rate effective February 1, 2023

WHEREAS, the successful bidder for KGID's three-year snow removal contract which commenced October 1, 2022 bid equipment rates 20% higher than the rates in the previous contract; and,

WHEREAS, the Board of Trustees awarded a three-year contract to the bidder to ensure that snow removal service would continue be provided to the District's customers; and,

WHEREAS, in 2017 recognizing the series of less than normal precipitation and snow removal expense years, the Board of Trustees, reduced the monthly unit rate from \$22.25 (established in 2004) to \$15.00 in order to reduce the year-end balance and not have surplus funds in the account; and,

WHEREAS, a snow removal fee rate increase is needed to keep the Snow Fund selfsustaining under the snow removal rates, vehicle and capital replacement plans and other increasing expenses; and,

WHEREAS, snow removal costs and deliberations occurred in two meetings of the Board of Trustees, in September, and October 2022; and,

WHEREAS, on December 13, 2022, by Motion XXXXX the Kingsbury General Improvement District Board of Trustees declared its intent to raise the snow removal fee rate per unit to \$20.25 per month effective February 1, 2023, \$24.50 effective January 1, 2025, and \$26.50 effective January 1, 2027; and,

WHEREAS, recognizing that due to heavy weather or other impacts, the new rates may not recover funds necessary for the next fiscal year, the board of trustees finds that unless the ending year balance exceeds one million dollars, the next successive rate will be imposed on January 1st of the following year; and,

WHEREAS, display ads noticing a public hearing on the proposed increase were published in the Record Courier on October 29, 2022 and notices were also included in the October and November bills; and,

WHEREAS, the Board of Trustees conducted a public hearing on December 13 regarding the proposed snow removal fee rate increase;

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the snow removal fee rate per unit will increase to \$20.25 effective February 1, 2023, \$24.50 effective January 1, 2025, \$26.50 effective January 1, 2027 with provisions for administrative implementation of the next tier should year-end balance fall below one million dollars.
